Meeting Date: 2018.10.19 October meeting.

- Bud Mackey announced the Commissioners' Court passed a resolution making the Veteran's groups responsible for the County Cemetery on FM 195 (the city and county will provide labor, the Veterans groups will supervise). As a consequence we need volunteers. Bud also announced:
- The State of Texas had passed a resolution on the proper burial of indigents (including Veterans), and that we as a Veteran service organization can help properly honor deceased Veterans by providing military honors during internment;
- A university group may assist the Veterans by use of a ground penetrating radar to locate existing unmarked graves in the cemetery;
- The Veteran groups will designate plats in the cemetery for new graves.
- The post needs volunteers for County Cemetery Committee. Don Karasek, Bud Mackey, Charles Miles, Ora Miles, Teresa Fergurson, Wyndell Ferguson volunteered to be members of the committee.
- Keith Brown asked if the Investment Review Committee had any results to report. Bud stated some research had been completed, but the report is not complete. Due to other commitments, Amy asked to be removed from the committee. Commander Karasek agreed and appointed Ora Miles and James Council to the committee.

New business included:

- The Post discussed putting the financial report on the webpage. Bud Mackey moved "The financials will not be posted on the website." Don Karasek seconded the motion. Amy Burton amended the motion to state "The financial reports will not be posted on the website, but they will be made available to Post members upon request." Ora Miles seconded the Amendment. The amendment passed by voice vote. The amended motion passed by voice vote.
- Commander Karasek announced the post has new business cards.
- Bud Mackey moved the post make an initial purchase of 20 lapel flags and pins for new members. Amy Burton seconded the motion. The motion passed by voice vote. Commander Karasek announced he will place the order.
- Bud Mackey will schedule a financial audit meeting. Attendees will include James Council \& Willie Wooten as Post Trustees and Keith Brown as Judge Advocate.
