**Meeting Date**: 2018.11.17 November meeting.

American Legion Brown-Guest Post 30 met at the Paris Elk's Lodge at 10am.

The Post Commander, Don Karasek, called the meeting to order, submitted his resignation, and left. The Vice Commander acted as the Interim Commander for the remainder of the meeting.

The Service Officer submitted a written report regarding the Tricare Dental Plan.

The post welcomed new members: David Booker (US Army), Lisa Dawes (USAF).

The Adjutant moved the post accept the new members. Keith Brown seconded the motion. The motion passed by voice vote.

## Unfinished business:

- The Adjutant stated new member kits were ordered and had arrived.
- The Post 30 Cemetery Committee will meet with members of the other Lamar County Veteran Organization Cemetery Committees at the Reno Fire Department (after Thanksgiving, at a date and time to be announced later)
- The Judge Advocate submitted the **Audit Committee Report** to the Adjutant.
- The Adjutant submitted the **Executive Committee Report**.

 The District Commander stated he will send the Adjutant the appropriate form for documenting the number, serial numbers, and condition of each rifle provided by the US Army and stored at the Paris PD armory.

## New business included:

- The Service Officer made the motion: "Post 30 will volunteer, as a group, to stock the Downtown Food Pantry on one (1) Tuesday in the January-to-March quarter of 2019". Keith Brown seconded the motion. The motion passed by voice vote.
- Keith Brown made the motion: "Post 30 will reimburse Bud Mackey the \$50.12 he spent buying office supplies for the post." James Council seconded the motion. The motion passed by voice vote.
- The membership considered opening a revolving account with Paris Office Equipment. Bud Mackey stated they required a monthly minimum purchase of \$500 to open such an account.
- The District 1 Commander announced:
  - Regional Adjutant Training will be held at the Sulphur Springs VFW Post 8560 on 1
    December 2018 from 0800-1600. There is no charge for the training.
  - The District 1 Convention will be held on 9 March 2018 at Post 161 in Maud, Texas.
  - The Division 1 Convention will on Saturday 27 April 2019. The event will be sponsored by Dallas Post 453 at the MCM Elegante Hotel.

  - In District 1 (of 19 posts) Maud Post 161 was number 1 for membership and Post 30 was number 2.
  - The Adjutant should download and submit the "TEXAS LONE STAR RECRUITER PIN" Certification Form so members can be properly acknowledged for their recruitment efforts.
  - The availability of 1<sup>st</sup> Division, 1<sup>st</sup> District American Legion t-shirts (\$10 each).
- The Adjutant asked Keith Brown to read a list of **Proposed Standard Operating Procedures**. A discussion ensued. Amy Burton moved, "**Post 30 Lay upon the Table the issue of SOPs.**" Attrell Harvey seconded the motion. The motion passed by voice vote.

- Mike Hanlon to resign as Chaplain, and stated that Billy Shepherd, a pastor, had agreed to serve if elected. Mike resigned. The membership approved Billy Shepherd as Chaplain.
- Keith Brown moved: "Post 30 will hold a Christmas dinner for post members and 1 guest per member in December. The cost to be paid by post funds." Amy Burton seconded the motion. The motion passed by voice vote. Bud Mackey moved that: "The Christmas dinner will be held at the Paris Elks Lodge on December 10<sup>th</sup> at 1900 hours." Amy Burton seconded the motion. The motion passed by voice vote. Keith Brown moved: "Post 30 accept the District Commander's recommendation that the dinner be open to neighboring posts including Deport, Clarksville, and Cooper; and the cost of each such guest will be the responsibility of that individual; and that all who plan to attend will RSVP to the Post Adjutant, not later than midnight 3 December." Amy Burton seconded the motion. The motion passed by voice vote.
