Unfinished Business: none

New Business: Commander, H.E. Mackey put to the floor that the post pays the \$100 for the wreath for Eric Pearson. Rick Leonhardt motioned to donate the \$100 for the wreath. Kip McClinchie seconded. Motion passed by unanimous vote.

Keith Brown motioned to donate a \$300 derringer pistol to raffle in memory of Eric Pearson. Rick Leonhardt seconded. Motion passed by unanimous vote.

Post Recruiting Award in recognition of achieving 10% or higher increase over previous year for the 2019 membership.
